To All Prospective Bidders:

The Fortuna Elementary School District (District) herewith issues Addendum No. 2 to the above-referenced solicitation. This Addendum shall be made part of the Contract Documents and the bidder shall acknowledge receipt thereof on the Bid Proposal Form. Except as specifically modified by this document, all other terms and conditions remain in full force and effect.

1. The District requests the furnace model number Lennox SLP98UH070XV36B in order to have equivalent units across the district, see attached specifications. The equivalent BTUH requirement for the furnaces has been removed as this furnace is not available in the 40,000 BTUH size.
2. In the Scope of Work, section 1, table 1:

The Equivalent Input BTUH should be struck.
