Minority, women, and disabled veteran contractors are encouraged to submit quotes. This project is not subject to Disabled Veteran Business Enterprise requirements. With the work scheduled during a school break, contractor fingerprint certification is not required.

A copy of the contract is available upon request. Contractors and subcontractors performing work on District public works contracts shall pay prevailing wages as determined by the Department of Industrial Relations (DIR). It is not required but is preferred that the contractors be registered with the DIR to perform Public Works.

The District reserves the right to postpone selection for its own convenience, to withdraw this Request for Quotes at any time, and to reject any and all submittals without indicating any reason for such rejection. Submitted quotes become the property of the District.

Site Visit: A pre-bid site visit will be held to acquaint all prospective bidders with the Project site at 3:00 pm, Thursday, March 21, 2019. Attendance is strongly recommended. All questions presented should be submitted in writing.

Site visit will be at Ridgewood Elementary School - 2060 Ridgewood Dr, Eureka, CA 95503. Please meet in front of the school office.

Insurance Requirements (summary only - see contract for full requirements):

General Liability: \$1 million combined single limit personal injury and property damage

for each occurrence and \$2 million annual aggregate; or \$2 million

annual combined single limit

Builders Risk: Not required

Automotive: Covering bodily injury and property damage in an amount no less than

\$1 million combined single limit for each occurrence.

Certificates for the insurance policies must be provided naming the District as additional insured. See contract for details.

Proof of Workers' Compensation insurance, waiver of subrogation and employer's liability of at least \$1 million is required. See contract for details.

Bond Requirements: With project value under \$25,000, no payment or performance bonds are required.

Bid Security: With a contract value less than \$15,000, only informal quotes are being requested; therefore, no bid security (e.g., 10% cashier's check or bid bond) is required.

Quote Submittals: Contractors providing quotes need to complete the attached Proposal form, Subcontractor List Form, and Workers' Compensation Certificate. Please enclose all documentation with your proposal. Quotes should be good for at least 30 days from the date of submittal. Prices must be quoted F.O.B. Cutten Elementary School District.

After a contractor is selected by the District and the Notice of Award is issued, failure to deliver the executed contract along with the certificates of insurance (subject to review by the District's Risk Manager) in a timely manner (e.g., 10 days) may result in cancellation of the award of contract and selection of another contractor to perform the work.

SCOPE OF WORK

The selected contractor will:

- 1. **Base Bid:** Provide and install all labor and materials for a code compliant installation of one (1) dedicated, 30-amp, 208/240-volt circuit and non-fused disconnect to serve outdoor unit of new heat pump to be located in classroom 6.
 - a. Location
 - i. See Appendix 1 for a Site Map.
 - ii. Derive power from existing Westinghouse CDP-type, 120/208-volt Panelboard at west end of the main classroom building.
 - iii. Install non-fused, NEMA 3R disconnect to be wall mounted on north side of the building outside classroom 6. Coordinate location with project manager and HVAC contractor.
 - b. Mechanical
 - i. Provide and install one (1) new 2-pole, 30-amp breaker in the existing service panel.
 - ii. Provide and install dedicated 30-amp circuit including ³/₄" conduit with (3) #10 conductors and (1) #10 ground to disconnect at exterior wall location.
 - iii. Provide and install (1) non-fused, weather proof, NEMA 3R, disconnect on north wall to serve new outdoor unit.
 - iv. Provide and install flexible conduit between disconnect and outdoor unit.
 - v. All conduits to be outdoor rated with weather tight connectors.
 - c. Structural
 - i. Provide support for conduit and disconnect as needed.
 - d. Permitting and Reporting
 - i. Report costs and other information as needed to meet Prop 39 reporting requirements.
 - ii. Provide invoices and other information as needed to meet PG&E rebate requirements.
 - e. Title 24
 - i. System must comply with 2016 Building Energy Efficiency Standards (Title 24, Section 6)
- 2. Coordinate with the District and Redwood Coast Energy Authority to ensure adherence to Proposition 39 program guidelines
