This work requires a <u>B - General</u> or <u>C-20 - Warm-Air Heating</u>, <u>Ventilating</u>, and <u>Air-Conditioning Contractor</u> license.

Minority, women, and disabled veteran contractors are encouraged to submit quotes. This project is not subject to Disabled Veteran Business Enterprise requirements. With the work scheduled during a school break, contractor fingerprint certification is not required.

A copy of the contract is available upon request. Contractors and subcontractors performing work on District public works contracts shall pay prevailing wages as determined by the Department of Industrial Relations (DIR). It is not required but is preferred that the contractors be registered with the DIR to perform Public Works.

The District reserves the right to postpone selection for its own convenience, to withdraw this Request for Quotes at any time, and to reject any and all submittals without indicating any reason for such rejection. Submitted quotes become the property of the District.

Site Visit: Contractors bidding on this project must have visited the site to familiarize themselves with the scope-of-work of the project and site irregularities.

Insurance Requirements (summary only - see contract for full requirements):

General Liability: \$1 million combined single limit personal injury and property damage

for each occurrence and \$2 million annual aggregate; or \$2 million

annual combined single limit

Builders Risk: Not required

Automotive: Covering bodily injury and property damage in an amount no less than

\$1 million combined single limit for each occurrence.

Certificates for the insurance policies must be provided naming the District as additional insured. See contract for details. Proof of Workers' Compensation insurance, waiver of subrogation and employer's liability of at least \$1 million is required. See contract for details.

Bond Requirements: With project value under \$25,000, no payment or performance bonds are required.

Bid Security: With a contract value less than \$15,000, only informal quotes are being requested; therefore, no bid security (e.g., 10% cashier's check or bid bond) is required.

Ouote Submittals: Contractors providing quotes need to complete the attached Proposal Form, Subcontractor List Form, and Workers' Compensation Certificate. Quotes should be good for at least 30 days from the date of submittal. Prices must be quoted F.O.B. Fieldbrook Elementary School District.

After a contractor is selected by the District and the Notice of Award is issued, failure to deliver the executed contract along with the certificates of insurance (subject to review by the District's Risk Manager) in a timely manner (e.g., 10 days) may result in cancellation of the award of contract and selection of another contractor to perform the work.

- 1. Provide and install new ventilation fan for kitchen hood.
 - a. Demolition
 - i. Remove existing ventilation fan.
 - ii. Ensure proper disposal.
 - b. Mechanical
 - i. Provide and install new ventilation fan with EC motor.
 - ii. Existing hood and ductwork should be used.
 - iii. CFM of new fam must be equivalent to existing.
 - c. Electrical
 - i. Disconnect and reconnect power in the same location.
 - d. Structural
 - i. Structure of existing hood should not be modified.
- 2. Provide and install new fire suppression system for kitchen hood.
 - a. Code Compliance
 - i. System must comply with UL 300
- 3. Coordinate with the District and Redwood Coast Energy Authority to ensure adherence to Proposition 39 program guidelines.

 - b. To comply with Proposition 39 reporting requirements, Contractor will report post-installation costs by measure.
- 4. In addition to completing the scope defined in (1) and (2):
 - a. Verify all ventilation fan and fire suppression system are operational post installation. If not operational, correct and verify.
 - b. Provide briefing on the installed equipment and proper operation to school facilities manager.

- (b) By securing from the Director of Industrial Relations a certificate of consent to self-insure, which may be given upon furnishing proof satisfactory to the Director of Industrial Relations of ability to self-insure and to pay any compensation that may become due to his employees."

I am aware of the provisions of §3700 of the Labor Code which require every employer to be insured against liability for workers' compensation or to undertake self-insurance in accordance with the provisions of that Code, and I will comply with such provisions before commencing the performance of the work of this Contract and will require all Subcontractors to do the same.
