

**REDWOOD COAST ENERGY AUTHORITY (RCEA)  
ELECTRIC VEHICLE REBATE PROGRAM  
TERMS AND CONDITIONS**

**1. ELIGIBILITY:**

- a. Residential, business, non-profit, or government agency customers may apply. Applicant must be an existing RCEA Community Choice Energy customer with service account holder with account that is paid and current as of the date of application.
- b. Residential customer applicants must have registered vehicle with the California Department of Motor Vehicles (DMV) at the applicant's RCEA service account address.
- c. Business customer applicants must have registered vehicle with the California DMV at a location within Humboldt County.
- d. Applicant shall be eligible under and approved by the California Clean Vehicle Rebate Project (CVRP) prior to submitting RCEA rebate application.
- e. Application including all supporting documents must be received no later than 3 months after approval by the State of California for rebate under the CVRP.

- 2. RESTRICTIONS:** One rebate per residential or business account service address. For multifamily residences with a shared electric account, one rebate per unit number. RCEA staff and Board of Directors are ineligible to apply.
- 3. REBATE PAYMENTS:** Rebate payments will be made by check made payable to the electric service account holder and will be issued within 30 days following application approval. For service accounts held in more than one name, rebate checks will be issued payable to the applicant. RCEA reserves the right to request a completed and signed IRS Form W-9 before releasing the rebate payment.
- 4. LIMITATIONS:** Rebates are subject to funding availability. Applications will be processed and rebates issued on a first-come first-served basis until funding is depleted or the RCEA rebate program is terminated. Submittal of a completed application will not guarantee receipt of a rebate. Applicants placed on a waiting list may qualify for the rebate if additional funds become available. RCEA reserves the right, in its sole discretion, to determine the completeness of an application, to reject any application, to deny a rebate payment after approval to any applicant deemed by RCEA to be in violation of any term or condition of either the RCEA program or the CVRP, or to deny a rebate payment after approval to any applicant deemed by RCEA to have intentionally misrepresented information provided with the application.
- 5. FRAUDULENT APPLICATION:** Any rebate issued that RCEA later determines was obtained through fraudulent action of the applicant shall be refunded in full and shall be subject to payment of a 10% penalty. RCEA shall be entitled to an award of attorney's fees and costs in the event it brings an enforcement action to collect such fraudulently procured funds.
- 6. TAX LIABILITY and CREDITS:** RCEA is not responsible for payment of any taxes which may be imposed on the customer as a result of the rebate. The customer is solely responsible for identifying and applying for tax credits, if any are available.
- 7. DISPUTES:** Except where otherwise limited by law, RCEA reserves the right, in its sole discretion, to make final determinations regarding any disputed issues, including but not limited to eligibility and rebate amount.
- 8. PROGRAM CHANGES:** RCEA reserves the right to change, modify, or terminate this rebate program at any time without liability.
- 9. PROGRAM EXPIRATION:** The rebate program will expire upon the occurrence of the earliest of: (i) depletion of funds, or (ii) termination by RCEA of this rebate program.
- 10. DISCLAIMER:** RCEA makes no guarantees, representations, warranties, or endorsement, express or implied, regarding any vehicle acquired and subject to a rebate under this rebate program. Use of any such vehicle is at the applicant's risk. The applicant releases and holds RCEA harmless from any and all loss or damages the applicant may suffer arising from applicant's participation in this rebate program and acquisition of an electric vehicle.
- 11. CUSTOMER INFORMATION DISCLOSURE AUTHORIZATION:** By signing and submitting the Rebate Application, the applicant affirms that they are the holder of the service account identified in the Application, or an authorized representative thereof, and authorize RCEA's use and disclosure of customer's name as a participant in this rebate program.
