



## COMMUNITY ADVISORY COMMITTEE **APPLICATION**

The Redwood Coast Energy Authority seeks passionate, committed and diverse applicants representative of Humboldt County's many people and communities for its volunteer Community Advisory Committee (CAC). Applicants from all ethnicities, genders, sexual orientations, ages, and socio-economic backgrounds are encouraged to apply.

RCEA's mission is to develop and implement sustainable energy initiatives that reduce energy demand, increase energy efficiency and advance the use of clean, efficient and renewable resources available in the region for the benefit of the residents of Humboldt County and its cities.

RCEA's Board of Directors created the CAC to support the agency's public engagement efforts and provide decision-making support and input to the RCEA Board.

Fifteen Humboldt County residents serve on the CAC for 2-year terms. RCEA's Board Directors nominate 11 members, and up to 4 seats are filled through an open application process. The RCEA Executive Director develops the CAC's meeting agendas, which may include Board requested items.

### **Commitment and Expectations**

The CAC meets in Eureka every other month from 6-7:30 p.m. From time to time, they schedule additional meetings to address specific topics. When the need arises, the CAC may be asked to help plan and conduct meetings to educate and/or get input from the community on RCEA programs.

*CAC members commit to attend agreed upon meetings, prepare for meetings, and take responsibility for assignments between meetings. If a committee member is unable to participate fully and has frequent absences, the Board will replace the member. Physical attendance is preferred, however occasional online attendance may be possible if California open meeting law requirements are met.*

*CAC members commit to supporting RCEA's mission and to align their advice with the long-term success of the agency. The CAC is a Brown Act, California open meeting law compliant body. The public is notified of, and has a right to attend, all CAC meetings. CAC members are subject to all applicable conflict of interest laws. Appointees must complete a Fair Political Practices Commission Statement of Economic Interest, a public document disclosing the member's personal financial interests.*
