



## REBATE RESERVATION REQUEST EQUIPMENT REBATE PROGRAM

The purpose of this form is to request the reservation of rebate funds for 90 days for projects that have not yet installed. **Once your installation is complete, you must also submit a Complete Application Package (as defined in the Equipment Rebate Program Terms and Conditions) to initiate rebate processing.** If your project is fully installed, please skip this Rebate Reservation Request and proceed directly to submitting an Equipment Rebate Program Application and supporting documents. Rebates are limited to \$3,000 (residents) or \$5000 (commercial) per calendar year for your site. Rebates are available without a Rebate Reservation on a first-come, first-served basis while funding lasts. RCEA will make a determination in its sole discretion whether a submitted Request is complete. Upon RCEA approval of the Request (“Reservation”), the rebate amounts listed above will be reserved for 90 days. If a “Complete Application Package” (as defined in the Equipment Rebate Program Terms and Conditions) is not submitted within 90 days of the start of your Reservation, the rebate funds will no longer be reserved. Reservation extensions will be considered on a case-by-case basis. Submission or approval of this Request is not a guarantee of receiving rebate funds.
