REDWOOD COAST ENERGY AUTHORITY (RCEA) ELECTRIC VEHICLE REBATE PROGRAM - RESIDENTIAL TERMS AND CONDITIONS Version 3/21/2025

- **1. ELIGIBILITY:** Customers eligible to receive an RCEA Electric Vehicle Rebate ("EV Rebate") under RCEA's Residential Electric Vehicle Rebate Program ("Program") must:
 - A. Be a new or existing RCEA Community Choice Energy (CCE) residential electricity customer account holder for at least six months prior to the application date of a service account that is paid current as of the date of application,
 - B. Submit a complete and properly completed application,
 - C. Register the qualifying Electric Vehicle with the California Department of Motor Vehicles (DMV) at the applicant's RCEA service account address, and
 - D. Purchase the qualifying Electric Vehicle from a licensed automobile dealership within 180 days of the submission of a Complete Application Package.
- 2. **RESTRICTIONS:** Maximum of two EV Rebates for distinct EVs (unique Vehicle Identification Numbers or "VINs") per residential account service address (or unit number for multifamily residences with a shared electric account). Any RCEA rebates issued prior to May 2024 for an electric vehicle will not count against this maximum restriction.
- **3. APPLICATION:** A complete application ("Complete Application Package") must include all required information as detailed below, and any additional information or documentation that may be required by RCEA.
 - 1. Applications must be signed by the Applicant. The Applicant must be the person identified in the RCEA Account Name as it appears on the electric bill. Assignment of rebate payments may be made only by the Applicant to a resident of the household where the RCEA electric service is provided. RCEA will make a determination in its sole discretion whether a submitted application is complete. Failure to submit a Complete Application Package may result in delay or rejection of a filed application.
 - 2. Requirements for a Complete Application Package:
 - i. A completed and signed Residential Electric Vehicle Rebate Application.
 - ii. A copy of your Proof of Purchase. See Section 4. below for Proof of Purchase requirements. Please submit copies only as Proof of Purchase will not be returned.
 - iii. Copy of California DMV vehicle registration showing EV registered at the RCEA account address listed in the application.
- 4. PROOF OF PURCHASE: A complete and legible copy of the Proof of Purchase, issued by the dealership, such as a bill of sale or purchase contract, must be submitted to RCEA as Proof of Purchase. The Proof of Purchase documentation must show: vehicle make, model, year, Vehicle Identification Number (VIN), sale price, purchase date, purchaser's name, purchaser's signature and dealer identification or dealer number. Submission of a Proof of Purchase that don't meet all requirements will require Applicant to provide additional documentation as requested by RCEA. Inability to meet Proof of Purchase requirements or provide additional documentation requested by RCEA will cause the application to be rejected.
- 5. REBATES: The EV Rebate amount is \$2,000 for a new or used Battery Electric Vehicle (BEV). EV Rebates will be issued through the mail to the CCE account holder or assigned EV Rebate Recipient within 30 business days following the submission of a Complete Application Package from an eligible and qualified applicant. EV Rebates will only be issued for purchase of Eligible Electric Vehicles as defined in Section 6.
- **6. ELIGIBLE ELECTRIC VEHICLES:** EV Rebates may be redeemed when purchasing an Eligible battery electric vehicle (BEV) as defined below. Plug-in hybrid electric vehicles are not eligible.
 - A. Eligible <u>new BEVs</u> must meet all of the following criteria:
 - i. Vehicle must be a light-duty BEV. This includes vehicle weight classes 1 (6,000 pounds and less) and vehicle weight class 2 (6,001 to 10,000 pounds).
 - ii. Purchase price, before tax, of the EV shall not exceed \$85,000.
 - B. Eligible <u>used BEVs</u> must meet all of the following additional criteria:
 - i. The model year is 8 model years old or newer at the time of purchase,
 - ii. The odometer miles at the time of purchase do not exceed 75,000, and
 - iii. The vehicle purchased (as identified by its unique VIN) has not received an RCEA EV Rebate with a minimum 24-month period prior to purchase date.
- 7. LIMITATIONS: EV Rebates are subject to funding availability; submittal of a completed application will not guarantee receipt of an EV Rebate. EV Rebates will be issued on a first-come first-served basis until funding is depleted or the Program is terminated. At RCEA's discretion, applicants placed on a waiting list may qualify for the EV Rebate if additional funds become available. All incentives are final, and customers are not eligible to apply for larger incentives from the same program should they become

- available. RCEA reserves the right to deny an EV Rebate to any individual deemed, in RCEA's sole discretion, to be violating the terms, conditions, and restrictions of the Program.
- **8. DISPUTES:** Except where otherwise limited by law, RCEA reserves the right, in its sole discretion, to make final determinations regarding any disputed issues about the Program, including but not limited to eligibility and EV Rebate amount.
- **9. PROGRAM CHANGES:** RCEA reserves the right to change, modify, or terminate the Program at any time without any liability except as expressly stated herein.
- **10. PROGRAM EXPIRATION:** The Program will expire upon the earliest to occur: (i) when funds are depleted, or (ii) when the Program is terminated by RCEA.
- **11. DISCLAIMER:** RCEA makes no guarantee, representations, or warranties, expressed or implied, regarding the implementation or use of products purchased pursuant to this Program. Use of any product and acceptance of materials used is solely the customer's responsibility.
- **12. CUSTOMER DISCLOSURE AUTHORIZATION:** By signing the EV Rebate Application form, the applicant confirms they are the service account holder of the account identified in the Application form, or authorized representative thereof, and authorize RCEA to disclose customer's name as a participant in the Program. Further, by signing the EV Rebate Application form, applicant confirms they have read and understand the Terms and Conditions listed above.
